Message from SCYAP's CEO

Dear SCYAP Stakeholders:

SCYAP continued to persevere through difficult times in 2021 as our communities adjusted to the ups and downs of the COVID-19 pandemic. The impacts of the pandemic have been significant for everyone, and SCYAP spent much of 2021 focused on the safety and well-being of our staff, foster parents, and youth. We were all reminded that SCYAP is not just a building or place, it is the people that represent our organization who are helping the vulnerable youth and families we serve. Our foster parents and our staff are the “faces” of SCYAP, and those “faces” will be how SCYAP is remembered. Simply put, our people are most important.

Through strong collective leadership, SCYAP implemented numerous policies and protocols to better protect everyone involved with the organization in 2021. We believe these efforts have directly contributed to safety and well-being maintained among our staff, foster parents, and youth. We are grateful that no child, foster parent, or staff member was lost to COVID-19 in 2021, and we thank our staff for their diligent efforts towards safety during this challenging time.

Looking back, SCYAP has adapted in many ways over the past two years, and I believe our ability to accept and embrace change is one of our organizational strengths. SCYAP has traditionally been an office-based, in-person service-delivery and work environment, and we have now added remote work and telehealth services. The primary goal of these changes has been continued high quality service delivery while maintaining the safety and well-being of everyone involved. One particular focus of SCYAP in 2021 was the implementation of a statewide tele-psychiatry program. In partnership with the Duke Endowment, SCYAP made statewide tele-psychiatry services available to children touched by the child welfare system. Quality services from a psychiatrist have been a longstanding need for children in foster care, and we were excited to launch this new telehealth initiative!

We continue to count on our foster parents and staff to make the difference in the lives of the youth and families we serve. We are extremely thankful to each foster parent for their willingness and dedication to help vulnerable youth. We also cannot thank our staff enough for their perseverance and willingness to adapt in so many ways. Their work towards SCYAP's mission with daily purpose is inspiring and contagious. Our partners and stakeholders have also remained gracious and generous during difficult times, resulting in continued financial support for our youth during a difficult year.



In 2022, SCYAP looks to embrace change, normalize COVID-19 safety measures, and invest towards growth. It is no secret that there is a tremendous need for additional foster families in South Carolina, and we are committed to a robust recruitment and licensing effort to better meet the needs of children who need a foster family. We also plan to grow our community-based behavioral health services, taking advantage of telehealth opportunities to better meet the needs of children and families who may not have access to office-based services. In particular, we foresee an increased focus and demand for mental health services for children stemming from the pandemic. We are well-equipped with out-patient clinics and in-home services, including licensed therapists and psychiatrists, to provide these services.

SCYAP remains well-positioned as South Carolina's leader in foster care and behavioral health services to vulnerable youth. We will look forward to continued success in 2022!

SCYAP is incorporated as the South Carolina Youth Advocate Program, Inc. within the State of South Carolina. The general management of the company is vested in the authority of the organization's Board of Directors. The Board of Directors assigns responsibility for the day to day operations of SCYAP to the Chief Executive Officer (CEO).



SCYAP was established in 1990 to provide out of home foster care for youth with special needs. Services began in Charleston, SC and quickly spread up the state's coastline. As the number of foster homes and youth and families being served by SCYAP increased, the State Office was relocated to Columbia; the original Charleston site became a regional office with an outpost in Beaufort, and additional regional offices were opened in Myrtle Beach, Columbia, and Greenville. other

Since our inception, SCYAP has grown in both our scope of work and service spectrum. While our largest program continues to be foster care, a significant part of our array of services now includes community-based services, in-home clinical and family preservation services, and out-patient mental health clinics.

SCYAP offers a comprehensive array of programs and services to youth and families dealing with difficult issues and crises situations. Our programs promote individualized treatment, flexible programming, case and cause advocacy, community-based and in-home interventions, and a positive approach to treating children and working with families.

Because of the nature and flexibility of our individualized programs, SCYAP maintains a broad and relatively inclusive admissions policy. Our programs serve both male and female clients and do not discriminate by race, color, religious creed, ancestry, gender, national origin, sexual orientation, gender identity, gender expression, or the seriousness or complexity of disability or need.

The target population of SCYAP is at-risk or children with special needs. We serve children with a broad spectrum of emotional, behavioral, mental, developmental, and medical needs who are in need of out-of-home therapeutic services, community-based programming, and/or in-home intervention.

Foster Care Services



SCYAP foster care focuses on the power of family. In a foster home setting, children who have suffered abuse and neglect have the opportunity to share in healthy family relationships, to experience positive parenting, to learn and practice pro-social skills, and to actively participate in community life.

SCYAP has two different types of foster care programs: Therapeutic Foster Care and Traditional Foster Care. Both of these programs provide a nurturing, safe and caring home to children who require placement away from their families; however, the intensity of services and the presenting issues of the child(ren) being served differ between the programs.

Therapeutic Foster Care is a family-based placement option for children in need of out of home placement, who have serious emotional, psychiatric, developmental, medical, and/or behavioral issues. Foster parents are specially trained to understand and respond to the special needs of these children and are supported by SCYAP staff throughout the child's placement in their home.

Traditional Foster Care is a family-based placement option for children in need of out of home placement, but who do not require the specialized interventions provided in Therapeutic Foster Care. The children served in Traditional Foster Care are often just entering the foster care system or are close to exiting the system to family reunification, adoption, or emancipation.

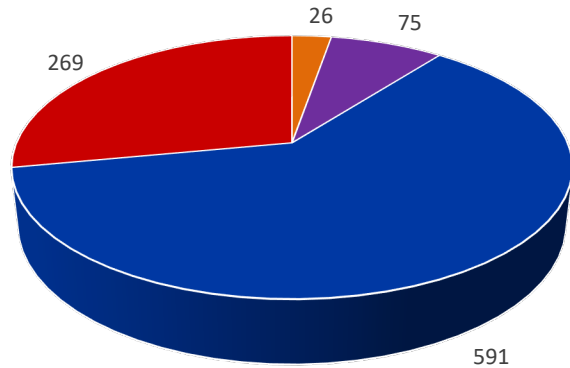

2021 Foster Care Client Population Demographics

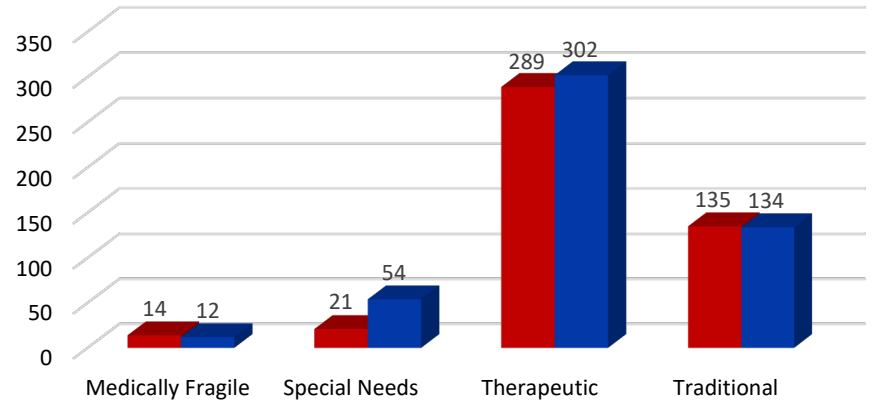

Clients Served by Foster Care Service



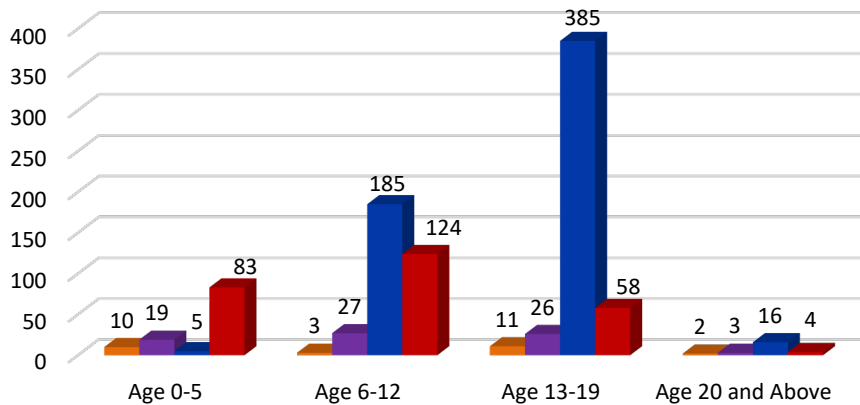

Clients Served by Gender and Type of Foster Care



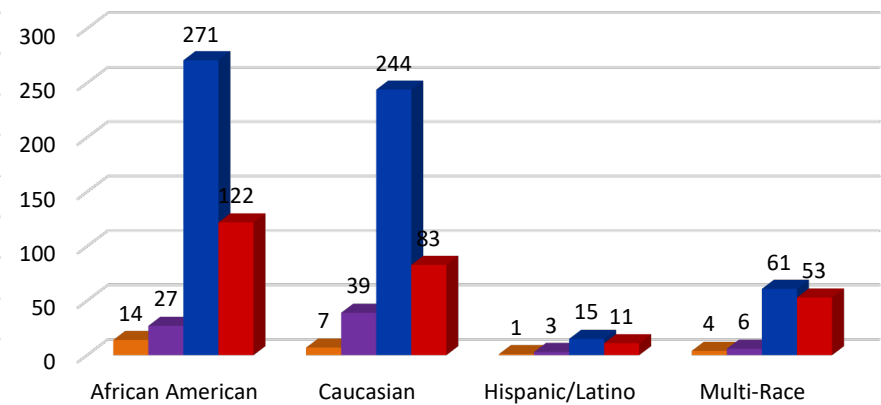

Mental Health Services

Mental Health Services are planned, face-to-face therapeutic interactions between a trained and qualified clinical professional and an individual recipient, a family unit, or a group of recipients with similar clinical needs. Our team of qualified mental health professionals provide clinical services to children, adolescents, and their families to address a wide variety of behavioral, emotional, psychiatric, and relational problems.



SCYAP's Mental Health Services are staffed with licensed mental health professionals. Comprehensive diagnostic and clinical assessments are used to identify the nature, cause and potential effects of a client's presenting problems, and are appropriate for clients who are just beginning to receive mental health services and for those who require a redetermination of the appropriate course of treatment to best meet their needs. Therapy services involve a range of clinical techniques, strategies, and modalities depending on the client's needs and diagnosis, and are aimed at helping the individual or family achieve and maintain stability, improving the mental and emotional health of the individual or family, and assisting them to cope or gain control over the symptoms and effects of their illness or life stressors. Psychiatric services, including assessment and medication management, are available and are provided by a board certified child and adolescent psychiatrist.



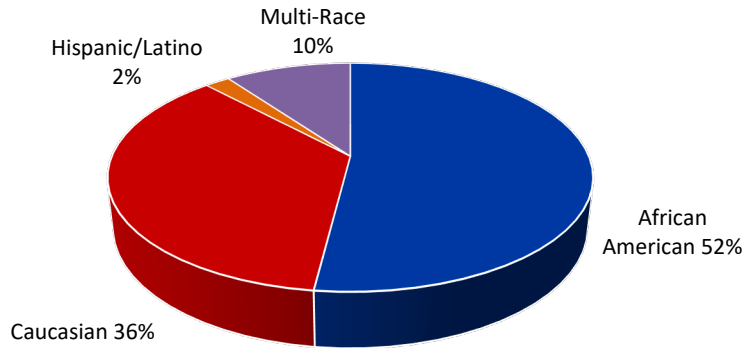
Mental Health Services are available through our out-patient clinics, through in-home services in the client's home, and throughout 2021, via telehealth services.

SCYAP is committed to providing trauma informed, family focused services to improve the lives of children and families. We are sensitive to the unique strengths and challenges of each child and are committed to helping overcome these challenges to improve the child's overall wellness and quality of life.

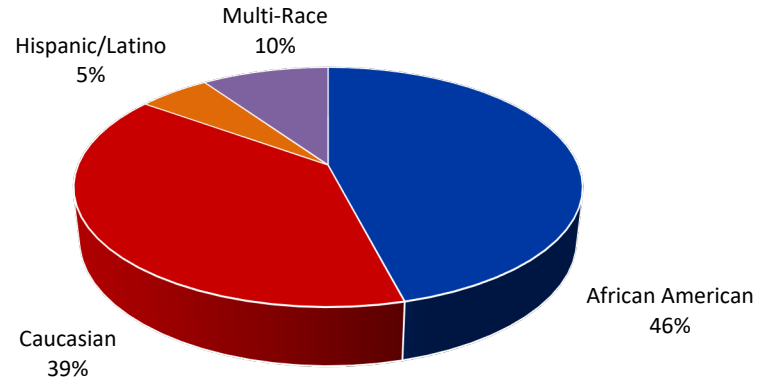
2021 Mental Health Services Client Population Demographics

 A total of 2131 clients were served through clinic services in 2021.

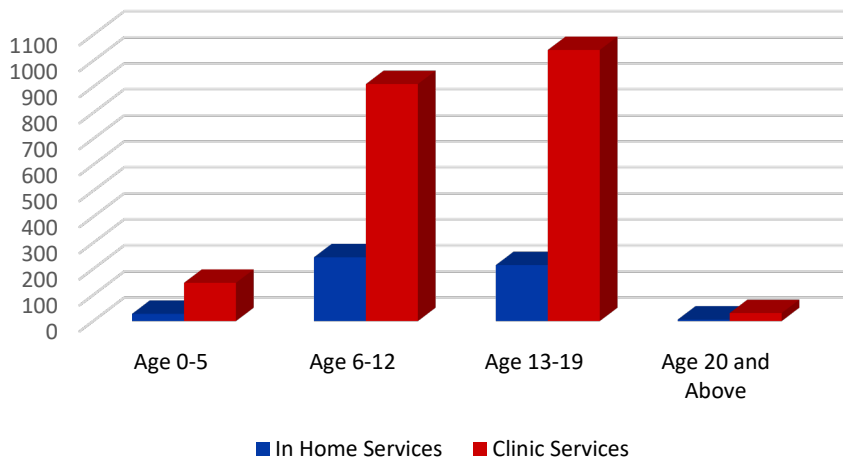
Race - In Home Services

Community-Based Wrap Services



Operating under the conviction that children and youth should be with their families and served in their communities whenever and wherever possible, SCYAP's Community-Based Wrap Services are non-residential services that are provided within the client's home, school, or community.

The overarching goals of the services provided in the SCYAP Community-Based Wrap Services array are to treat and maintain clients in their homes, to prevent out of home placements, to promote stability and positive family functioning, to prevent involvement with (or further involvement with) the juvenile justice system, and to develop a positive quality of life for clients and their families.

Behavior Modification Services provide the client with redirection and modeling of appropriate behaviors in order to enhance his or her functioning within the home, school, and/or community.

Psychosocial Rehabilitation Services assist clients in the strengthening of skills needed to promote and sustain daily living, independence and stability in their living, learning, social, and working environments.

Family Support Services enable the family or caregiver to serve as a knowledgeable member of the client's treatment team and to develop and/or improve the ability of the family or caregiver to appropriately care for the client.

Crisis Management Services assist the client or family to regain stability during an event that threatens the psychological and emotional well-being or safety of the client or others.

Transportation Services

are available to clients and family members for transportation to and from therapy services, court hearings, family visits and pre-placement visits.

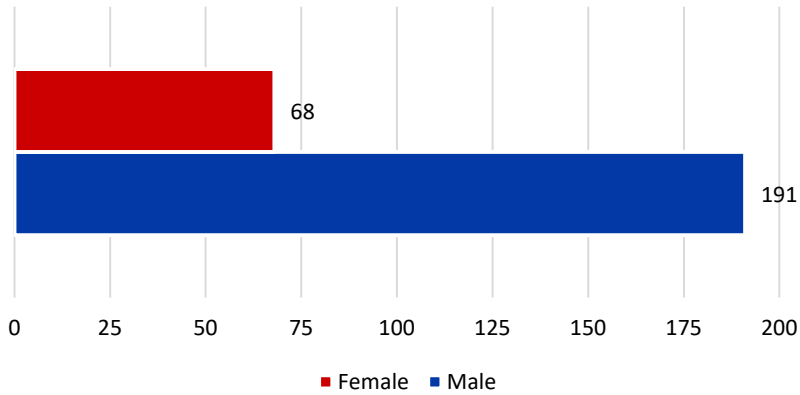
Transportation Services are provided statewide and out-of-state transportation is also available. A referral from a SC government agency is required for this service.

All Community-Based Wrap Services are available on a statewide basis and are provided at times when clients and their families can best access them (i.e., afterschool, in the evenings, on weekends, etc.).

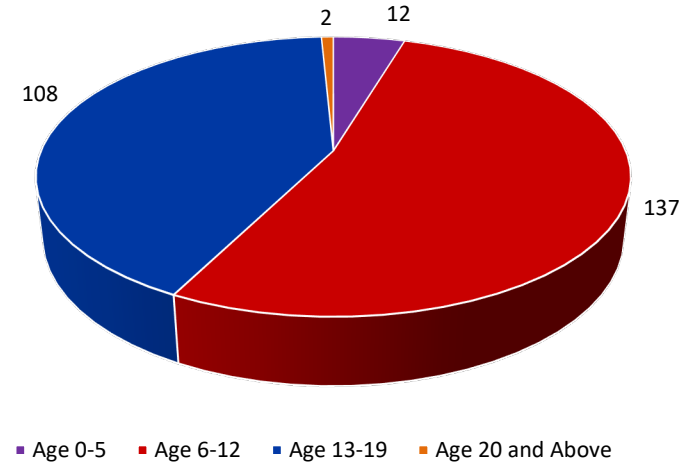
2021 Community-Based Wrap Services Client Population Demographics

A total of 259 clients were served by Community-Based Wrap Services in 2021.

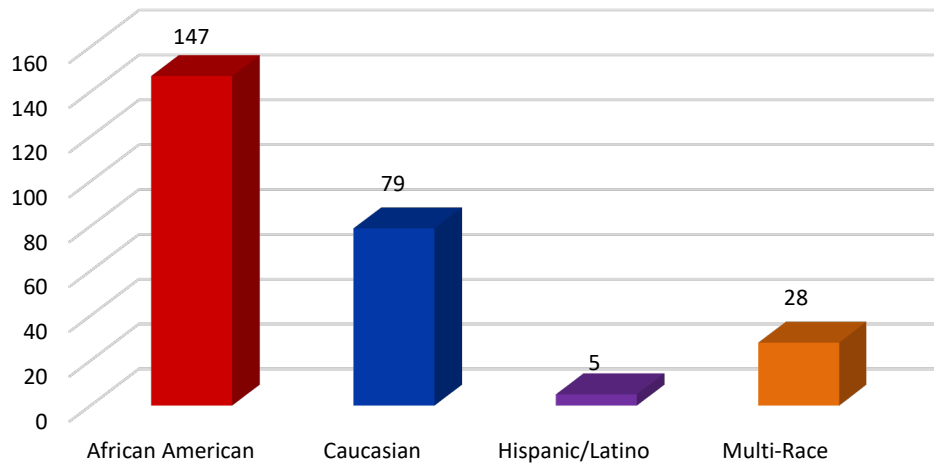
Clients Served by Gender




Clients Served by Age

In 2021, SCYAP's **Foster Care Services** continued to be the largest program, accounting for 74% of SCYAP's revenue.

Community-Based Services made up 5% of SCYAP's revenue in 2021.

Mental Health Services made up 16% of SCYAP's total revenue in 2021.

Transportation Services made up 3% of SCYAP's total revenue in 2021.

Other income, such as donations, contributions, grants, etc. made up 2% of SCYAP's total revenue in 2021.
